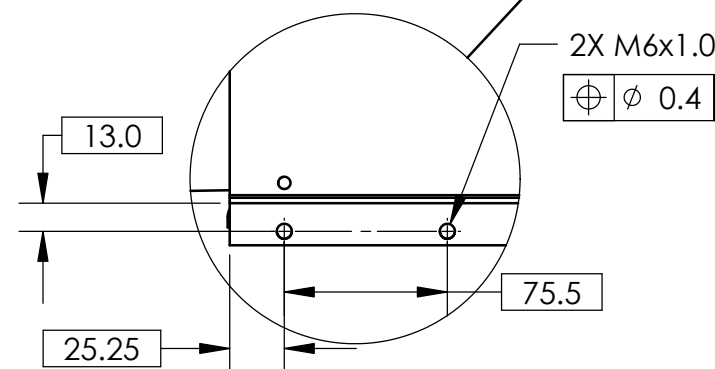

JUNCTION BOX DRILLING DIMENSIONS



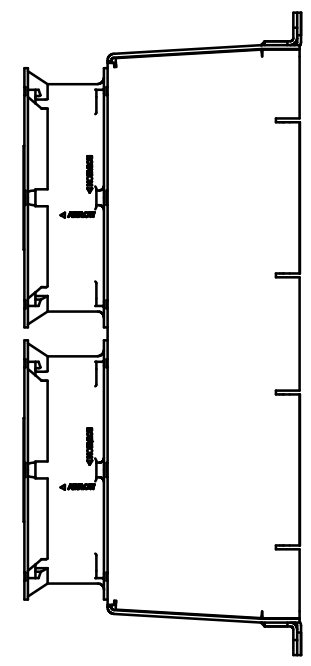
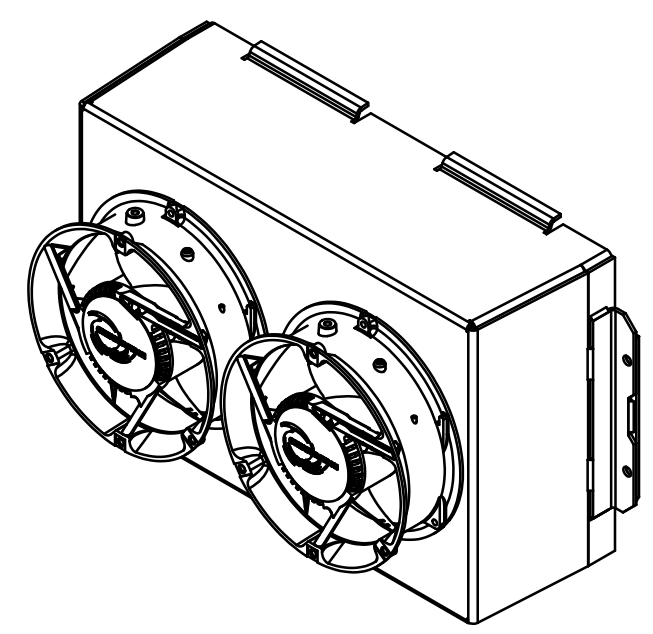
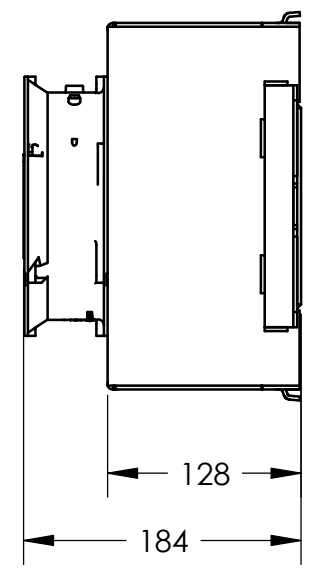
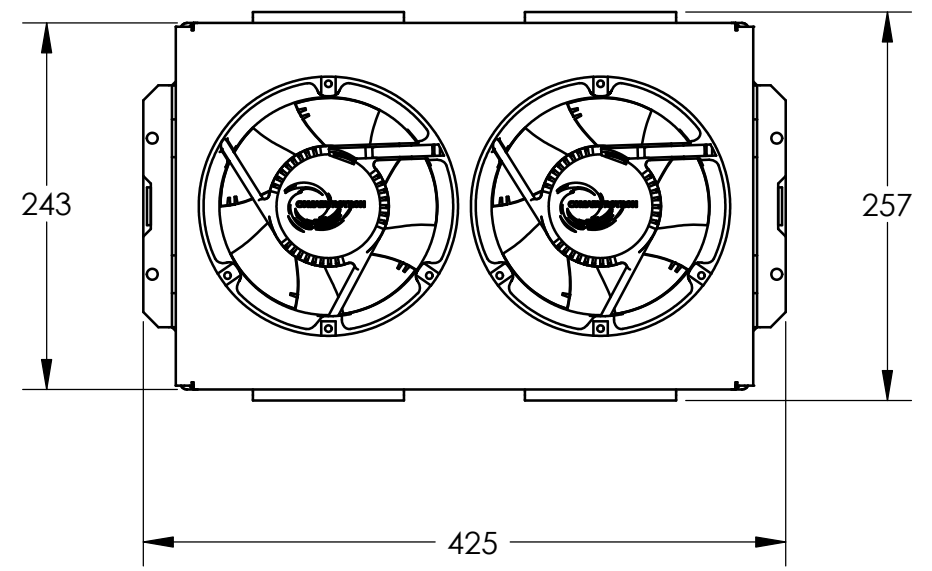
